Proof of Identity (**BRING ONE**)

- Original or Certified U.S. birth certificate, not hospital, with appropriate seal or stamp from government agency
- Valid United States Passport or Passport Card
- Certificate of naturalization or a consular report of birth abroad

NAME CHANGES - If your name is different from what is on birth certificate or passport, you must present a name trail of documents that link your name to your chosen proof of identity. These documents could include the following **ORIGINAL or CERTIFIED**:

1. Marriage Certificate issued by government agency not the church
2. Divorce Decree – Only if maiden name was restored back on decree.
3. Court Orders

Proof of Social Security Number (BRING ONE): (Visit www.socialsecurity.gov/ss5doc for documents needed to get a Social Security card)

- Social security card or any letter from the Social Sec. Administration with full name and SSN.
- W-2 form
- SSA – 1099 or Non - SSA – 1099
- Pay stub with applicant's name and full social security number on it
- * Customers may self-certify, but it must verify with social security

Proof of Residential Address (**TWO FROM DIFFERENT SOURCES**): **ADDR. CANNOT BE A PO BOX:**

- Deed, mortgage, monthly mortgage statement or payment booklet or rental/lease agreement
- Florida Voter Registration Card
- Mail from Federal, State, County and City Government agencies. May accept mail from DHSMV; including Florida Registration or Title on a vehicle or vessel.
- W-2 form or 1099
- Letter from shelter or half-way house verifying applicant resides at this address
- Utility bill or hookup/work order
- Auto/homeowner's insurance policy or bill. Or Auto Payment Booklet.
- Mail from financial institution
- Medical or health card with address. A medical bill.
- Educational institution transcripts
- Selective service card
- Form DS2019, Cert. of Eligibility for Exchange Visitor (J-1) status.
- Envelopes can be used as proof of residential address provided the customer's name is listed as receiver and the United States Postal Mark is displayed.
- Certification of Address Form HSMV 71120 (Rev. 2/13, See Back)

NEW: Customers with one proof of residential address may self-certify using the Certification of Address Form as the second proof of residential address document.

Individual's residing in Someone Else's Residence OR Minors residing with Parent or Legal Guardian

- Owner of residence must provide affidavit (See back)
- And, owner of residence must provide two different "Proofs of Residential Address" as listed above

NEW: Customers who reside with someone can self-certify using the Certification of Address Form and one proof of residential address in the person's name with whom they reside.

- o One proof of residential address in the customer's name or;
- o One proof of residential address in the name of the person with whom the customer resides. ***

* Homeless customers may present a letter listing the customer's name from a shelter, public assistance agency representative along with the completed Certification of Address form.

** Customers released from incarceration may present an Address Verification Letter from the Department of Corrections (with an Inmate Identification Card and Certificate of Discharge) along with the completed Certification of Address form.
